1. THE BURROUGHS AND MIDDLESEX UNIVERSITY SUPPLEMENTARY PLANNING DOCUMENT

This consultation statement has been prepared in accordance with Regulation 12(a) of the Town and Country Planning (Local Planning) (England) Regulations 2012.

2. Name of the Supplementary Planning Document (SPD)

Draft The Burroughs and Middlesex University SPD

3. PURPOSE OF THE DOCUMENT

This draft Supplementary Planning Documents (SPD) seeks to support the ambitions of enhancing the educational and civic offer The Burroughs provides to its existing communities in Hendon and as home to Middlesex University. It has been drafted in collaboration with key stakeholders and through engagement with ward councillors and local community representatives.

The next 10 years is set to bring new investment, transformation as well as the renewal of buildings, public spaces and community assets, all supported by improved infrastructure. This planning framework provides the context in which the Council seeks to engage comprehensive change delivered through a cohesive strategy. It seeks to enable the delivery of development that provides for the changing needs of the University, while recognising the importance of the residential community and the historic significance of the area.

In preparing the SPD, key stakeholders have been involved in the preparation of this planning document. Stakeholders include Ward Councillors, local residents and businesses, landowners and other community representatives.

Once adopted, the SPD will provide specific guidance on the implementation of Local Plan policies for future planning applications which come forward and will support further technical work which may be required (on transport options for example). It will be a material consideration when determining planning applications.

4. STAKEHOLDERS CONSULTED PRIOR TO THE PREPARATION OF THE SPD

In order to create a development framework which reflects the views of local stakeholders, the draft SPD has been produced through a collaborative process with the local community and stakeholders.

5. How were stakeholders consulted?

Engagement meetings with local Ward Members

A first meeting between the Planning Policy Team and local Ward Councillors was held on 25 February 2020 at Hendon Town Hall. The purpose of this meeting was to advise Councillors that work was progressing on the SPD for The Burroughs and Middlesex University, the extent of the SPD area, the content of the SPD and the process for preparing it. Ward members were also invited to attend the Community Stakeholders meeting held online September 2020. A walk around the SPD area with Members was also undertaken on 15 September 2020

Local Plan Consultation

Barnet's Regulation 18 Local Plan was published for public consultation in January 2020. The Reg 18 Local Plan included a number of proposals affecting sites in the SPD area. As part of the Reg 18 consultation letters were sent to resident and businesses near these sites.

Public consultation events were held in Colindale – 2 Bristol Avenue (Feb 10th 2020) and Hendon Town Hall (March 4th 2020), both attracted local residents from around The Burroughs area of Hendon. An event with boroughwide community groups was also held in the Meritage Centre in February 2020.

Written responses were received to the Local Plan consultation that related to Reg 18 site proposals in the SPD area. Verbal and written responses highlighted the following issues:

- Students and anti social behaviour

- Contribution of Middlesex University students to car parking and congestion issues in the area
- Requests for more controlled parking zones (CPZs) in the area and for these to be enforced
- Impacts on infrastructure including transport and health services

Covid -19

The Local Plan consultation closed on the 16th of March 2020. The UK went into full lockdown on the 23rd of March 2020. Even after the lockdown lifted it has not been possible to have in person consultation events. Once it became apparent that in person consultation events were not going to be possible the decision was made to hold an online event and invite Members and local residents. This online event was held in September 2020.

On-line event

The on-line event was held on 3rd of September at 6pm via (MS) Teams. An initial letter/email was sent out to local stakeholders inviting them to the event, asking them to reply if they were interested in attending. Those who replied were then sent the MS Teams invitation and a copy of the presentation, so that should they lose connection they could still view the presentation. Comments were invited. These reiterated the concerns raised at the Local Plan events and Local Plan responses, along with the additional matters of impact on the visual amenity of the area and how University graduates could be retained in the Borough.

Consultation with statutory consultees

As part of process in developing a SPD, a Draft Sustainability Appraisal was prepared to ensure that the social, economic and environmental matters were considered. Under UK legislation, through the Environmental Assessment of Plans and programmes Regulations 2004, the Council was required to consult with the following organisations:

- The Environment Agency
- Natural England
- Historic England

Consultees were sent a letter on 29th October 2020, along with a copy of the draft scoping report asking for comments by 3rd December 2020. The three statutory organisations responded to the consultation and the Sustainability Appraisal was changed as a result.

6. Summary of the main issues raised during initial consultations and how the council is responding

The initial consultation process enabled the SPD team to collect opinion from stakeholders to help inform the document. The following section highlights the key messages raised and how the Council are responding to these comments.
